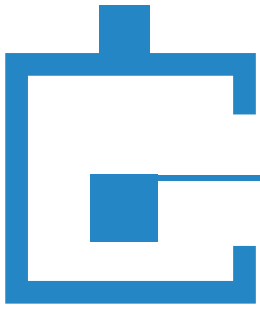

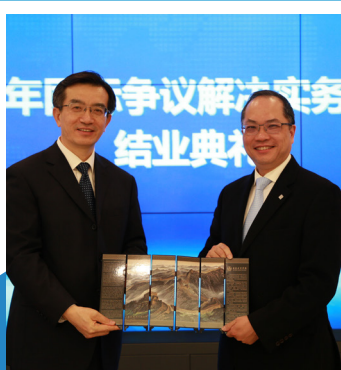

Promotion of Hong Kong as one of the Leading Centre for International Legal and Dispute Resolution Services in the Asia-Pacific regions.

Since 2018, IDRRMI has been and will always be promoting the best practice in risk management and dispute resolution systems for international businesses, professional bodies and governments. It is working closely with international Dispute Resolution organizations in the Legal Hub of Hong Kong to strengthen Hong Kong's position as a Leading Centre for International Legal and Dispute Resolution Services in the Asia-Pacific region.



In order to effectively implement the spirit of the "Outline Development Plan for the Guangdong-Hong Kong-Macao Greater Bay Area," an international dispute resolution practical training course, co-organized by our association, was successfully held at the National Judges College from December 8th to December 12th, 2019. At the closing ceremony, Mr. Luo Dongchuan, the then Vice President of the Supreme People's Court and a second-level senior judge, presented a commemorative gift to Dr. Law Wai-hung, the Chairman of IDRRMI.



On April 28th, 2021, witnessed by Mr. Liu Chunhua, the Minister of the Legal Department of the Liaison Office of the Central People's Government in the Hong Kong Special Administrative Region, a Memorandum of Understanding on the Mediation Standards Alliance was jointly hosted by the International Dispute Resolution and Risk Management Association, the Singapore International Mediation Centre, the Asian Mediation Association, the French Mediation Certification Association, and the Portuguese-speaking Mediator Certification and Training Institute.



On February 16th, 2023, with the strong support of the Central People's Government, the Inauguration Ceremony of the Preparatory Office of the International Mediation Institute was held in Hong Kong. According to the Joint Statement on the establishment of the International Mediation Institute, the Preparatory Office was established in the Hong Kong Special Administrative Region to carry out preparatory work for the establishment of the International Mediation Institute.

Dr. Law Wai-hung, the Chairman of our association, was invited by the Department of Justice of the Hong Kong Special Administrative Region to attend the inauguration ceremony.



The Legal Hub of Hong Kong

Hong Kong has a long and rich common law tradition, with a mature and highly transparent legal system that is known for its fairness and reliability. It has consistently performed well in international rankings. To reflect the importance and recognition of the rule of law and legal-related services in Hong Kong, as well as to consolidate and enhance its position as a hub for international legal services, facilitation of transactions, and dispute resolution in the Asia-Pacific region, the Hong Kong Special Administrative Region has allocated certain spaces in the Western Block of the former Central Government Offices (now known as the Justice Place), which is a Grade 1 historic building, as well as portions of the former French Mission Building, a declared monument, and the second tower of Exchange Square, for use by local, regional, and international legal-related organizations. Together with the offices of the Department of Justice located in the Central Government Offices' Main Block, East Wing, and parts of the Western Block, this area has become an international legal hub in Hong Kong's central business district.

The former Central Government Offices, now known as the Justice Place, is a Grade 1 historic building located in the Central district.

The headquarters of IDRRMI is currently located on the 5th floor of the West Block of the Justice Place at 11 Ice House Street, Central, Hong Kong Special Administrative Region.

It provides certifications for professional qualifications and intellectual property rights, as well as certifications for property rights and ownership. Additionally, IDRRMI offers comprehensive business solutions for enterprises and international organizations in various regions, including those along the Belt and Road Initiative, as well as for trade and commerce worldwide. These solutions encompass risk management, corporate governance system planning, and dispute resolution services.

Its jurisdiction for enforcement covers a wide range of regions, including those along the Belt and Road Initiative.

The services provided by the Centre include managing arbitration proceedings and rendering awards on types of disputes.



Hong Kong International Property Rights Protection Cloud Platform

The Hong Kong International Property Rights Protection Cloud Platform is designed to extend greater protection against intellectual property rights for the artworks, cultural industries, and intangible cultural heritage through a well-structured and authentic registration system. The registration of platform will strengthen the function of intellectual property valuation and will provide intact evidence in formal dispute resolution procedures

INTERNATIONAL DEVELOPMENT >>>

IDRRMI has more than 1,600 experts in a variety of professional categories worldwide. At present, IDRRMI has set up 12 branches and 13 representative offices around the world, and has established cooperation with more than 550 institutions, organizations, companies and government departments in more than 40 countries and regions around the world. IDRRMI collaborated with 40 international organizations for cross-recognition of professional qualifications. Since 2021, IDRRMI has been designated as an accredited NGO by the World Trade Organization.
